**ELIGIBILITY OF THE CANDIDATE:**

**1. For the post of Section Officer:**

- (a) Must have retired from the post of Section Officer / Senior Revenue Assistant (S.R.A.).
- (b) Must possess sound knowledge in drafting, establishment matters, service rules and office procedure.
- (c) Must have working knowledge of computer operation.
- (d) Must be of good character and sound health.

**2. For the post of Revenue Inspector:**

- (a) Must have retired from the post of Revenue Supervisor / Revenue Inspector / Assistant Revenue Inspector.
- (b) Must possess adequate field experience in revenue and land acquisition matters.
- (c) Must be physically fit and of good character.

**3. For the post of Data Entry Operator:**

- (a) Must have passed at least +2 Examination or equivalent from a recognized Board.
- (b) Must possess Diploma in Computer Application from a recognized Institute.
- (c) Must have working knowledge of MS Word, MS Excel, data entry and e-mail.
- (d) Must be above 18 years of age.
- (e) Must be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to M.E. standard.
- (f) Must be of good character and sound health.

**4. For the post of Amin:**

- (a) Must have retired from the post of Amin or Must have possess Amin certificate.
- (b) Must have practical knowledge and experience in land measurement and survey.
- (c) Must be physically fit and of good character.

**5. For the post of Chainman:**

- (a) Must have retired from the post of Chainman.
- (b) Must have experience in survey-related field work.
- (c) Must be physically fit and of good character.

**6. For the post of Process Server:**

- (a) Must have retired from the post of Process Server.

OR

- (b) Must be above 18 years of age.
- (c) Must be able to read and write Odia and must have passed at least M.E. standard.
- (c) Must be physically fit and of good character.

**N.B: Retired Government employees having experience in land acquisition work shall be given preference.**

**TERMS AND CONDITIONS:**

1. The contractual engagement shall be made till completion of the project.
2. The engaged personnel shall discharge duties as assigned by the Tahasildar-cum-Special Land Acquisition Officer, Nabarangpur.
3. Retired Government employees against whom any vigilance case, departmental proceeding or criminal case is pending or contemplated, or who have been penalized for misconduct during the last five years prior to retirement, shall not be selected.
4. The period of contractual engagement shall not be treated as Government service for pension or any other retirement benefits.
5. The engaged personnel shall abide by the conduct rules applicable to Government servants.
6. The contractual engagement may be terminated at any time without prior notice for unsatisfactory performance or misconduct.
7. In case of resignation, one month's prior notice in writing shall be required.
8. The Tahasildar-cum-Special Land Acquisition Officer, Nabarangpur reserves the right to reject any or all applications without assigning any reason thereof.
9. Applications in the prescribed format shall be submitted by Registered Post / Speed Post / Personal delivery so as to reach this office on or before **21.02.2026**. Applications received after the due date shall be summarily rejected.


